

Terms & Conditions for "Partner up. Earn big!" 2 months Partner Promotion

A. Introduction

This document describes the terms and conditions of "Partner up. Earn big!" 2 months promotion (the "Promotion") which is a Markets4you Partner promotion. All the Partners by default will qualify for this Promotion.

B. Participation in Promotion

his promotion will be introduced to the partner's community in 4 groups:	
☐ New IB (65% spreads and commissions)	
☐ New Multi-Level (Total 66% spreads and commissions)	
☐ Existing IB	
☐ Existing 5 Level Multi-level	

All new IB and Multi-Level partners who are registering from 1st Aug, 2024 onwards will be automatically enrolled to this promotion. Existing partners of Markets4you both IB and 5 Level Multi-level will be enrolled to participate in the promotion by default. However, partners who are already on the higher slab of revenue share will not be given extra or additional pay outs i.e. their payouts will no longer be dynamic.

Any new partners onboarded during this period of 2 months will be eligible for the promotion automatically.

C. Promotion Period and Trading Period

- 1. The Promotion period is the period of time that the promotion will be held.
- 2. The Promotion period runs from 1st Aug 2024 until 30th Sep 2024 (the "Promotion period").
- 3. The Trading Period is the period of time that the results for the Promotion will be collected.
- 4. The Promo period runs from 1st Aug 2024 until 30th Sep 2024 (the "Trading Period)



- 5. The payouts will be only for the closed trades during the aforesaid period of the promotion.
- 6. All the other payout terms & conditions remain the same for this promotion as well.
- 7. All new IB and existing Partner programs will not be eligible for the loyalty payouts during this period.

D. Promotion Terms

1. Registration:

Starting 1st Aug, 2024 all Partners will be getting 85% revenue share (65% of spread and commissions for IB, 66% spreads and commissions for 5 Level Multi-level). The participation of all Indian partners in the promotion is by default and does not require any special qualifier.

2. After 30th September, 2024 partners performance will be evaluated basis the following targets:

Total InOut: 30,000 USD

Total Lot: 200

- 3. Partners who are able to meet the above criteria between 1st Aug to 30th Sep after evaluating their individual performance they will continue to get the exclusive payout even after the promo period for an additional 1 month i.e. 1st Oct to 31st Oct, 2024.
- 4. On being unable to meet the above criteria during the given 2 month period (i.e. 1st Aug to 30th Sep), the partners will lose the special status and return back to their original status.



5. Tracking of progress:

- Markets4you reserves the right to evaluate the results based on performance of the partners and accordingly inform them.
- b. Should any discrepancies in data occur between Markets4you internal systems and any marketing communications, it is at Markets4you's discretion to decide the outcome and make changes in the terms and conditions of the promotion, if need be.
- c. Starting 1st Aug, 2024 all Partners will be getting 85% revenue share (65% of spread and commissions for IB, 66% spreads and commissions for 5 Level Multi-level). Partner results will be evaluated post 30th September, 2024. Based on their performance the partner payouts remain unchanged or partners who do not meet the minimum requirements, will by default going back to the original payout structure before this promotion.
- d. Since all existing partners will automatically participate in this promo, they will be shifted from any other existing partner programs that they are currently participating in to this promo and features of those existing promo within the Trade Room may not be accessible to them any further.
- e. Partners who are already earning more than the aforesaid percentage of revenue share will not be eligible in this promotion.

E. Lots and Orders

- 1. Only trades involving instruments based on (i) currency pairs, (ii) indices and (iii) commodities (iv) cryptocurrency qualify for the Promotion, that is, are taken into account in determining whether a particular client of a IB or Multi-level partner has satisfied the above mentioned minimum lot volume requirement.
- 2. Hedged orders are taken into account in their total full lot volume only in the event where the second order (opposite direction order) was opened not earlier than 3 hours after the first order had been opened. Should the period between the openings of two opposite directed orders be equal to or less than 3 hours, the smaller order's volume would be counted in the calculations.



- 3. Total traded volume is counted from closed orders. Any orders that are open at the end of Promotion will not be considered for the Promotion.
- 4. The deposit and traded volumes from all existing trading platforms will be assessed at the end of the Promotion Period.
- 5. All calculations are done on a Trader Room level and not per individual Partner accounts.
- 6. Markets4you will determine the final results of each Partner. Data will be derived from data of Partner's activity, but the Promotion result will not include:
 - a. Internal transfers;
 - b. Any other monetary activity that Markets 4 you deems unfit.

F. Reservation of Rights and Disqualification

- 1. Markets4you reserves the right at its reasonable discretion, to:
 - a. Decline registration to any participant in the Promotion.
 - b. Disqualify any participant of the Promotion who violates or abuses the terms of use of Markets4you services.
- 2. Only users who have registered with Markets4you and are from the relevant country (India) are eligible to participate in the Promotion. At any given time, we may ask the participant to provide personally identifiable information. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- 3. Markets4you reserves the right, at its reasonable discretion, to discontinue the Promotion without any prior notification.
- 4. Markets4you reserves the right to alter, amend or terminate the Promotion, or any aspect of it, at any time. Markets4you is not obliged to warn customers or partners about changes in the Promotion. The Partner is obliged to comply with all the rules and conditions of the Promotion, as well as monitor changes in the relevant terms and conditions.
- Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- 6. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the Promotion, the user will not be entitled to any reward. Participants who attempt to abuse the Promotion or manipulate their



- position in the Promotion will forfeit their reward in favor of the next chosen user in line in the Promotion.
- 7. If any participant is attempting to compromise the integrity or the legitimate operation of the Promotion by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets4you may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the Promotion and/or ban the user from participating in any of future promotion and other promotions.
- 8. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services. Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- 9. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
