

# **Lunar New Year Promotion Terms & Conditions**

### A. Introduction

The "Lunar New Year Promotion" is a Markets4you promotion (the "Promotion"). It is a special promotion program exclusively for the Lunar New Year 2025, where all clients, who deposit a specific amount and trade a specific amount of lots, can participate in the lucky draw (the "Promotion")

## B. Participation in "Promotion"

- a. Markets4you Clients who meet the following criteria can participate:
  - i. Eligible Accounts: Cent Fixed, Cent Pro, Classic Fixed, Classic Standard, Classic Pro, Classic Standard MT5 and MT5 Pro
  - ii. Country: Vietnam, Malaysia, China, Hongkong, Taiwan
  - iii. Trader Room must be verified

#### C. Promotion Period:

The Promotion will take place from 06 January 2025, 00:00 (server time) to 28 February 2025, 23:59 (server time) (the "Promotion period").

### D. General Terms

- a. Clients need to click the Participation Button in the Trader Room to participate in the "Promotion".
- b. During the promotion period, clients must make a minimum deposit of 500 USD and trade at least 4 lots during the promotion period to get 1 ticket.
- c. Clients can deposit and trade multiple times to get more tickets.
- d. The deposit count is derived from the following:
  - i. Direct Deposit from the payment system
  - ii. Deposits using Local Depositors
- e. Only trades involving instruments based on (i) Gold qualify for the "Promotion" and will be taken into account in determining whether a particular client has satisfied the above-mentioned minimum lot volume requirement.
- f. All opposing positions, whether held within a single trading room or across multiple trading rooms by the same client or a group of affiliated clients, will be excluded from the calculation of the total lots.
- g. Calculations of the total deposit amount from trading platforms and the total lot volume traded are made from closed orders.



h. Deposit bonus funds and lots traded on bonus funds (e.g., Deposit Bonus) will not be counted towards the client's participation in the "Promotion".

#### E. Awards and Winners

a. The winners of the "Promotion" will be drawn at random from the pool of eligible qualifiers and there are thirteen (13) winners in total for the draw, including 6 (six) winners for each monthly draw, and one winner for the Grand prize. The prizes are awarded according to the following table:

- b. Each winner can only win one (1) prize per draw.
- c. Winners will be announced on 7th February 2025 and 7th March 2025 via Markets4you official social media channels. On the 7th February 2025 we will announce the winners for the first round of lucky draw, and on the 7th March 2025 we will announce the winners for the second round of lucky draw alongside with the winner of Grand Prize.
- d. Markets4you reserves the right to draw eligible winners to substitute any winner subsequently found to be ineligible or disqualified. Markets4you's determination of the winner shall be final, conclusive, and binding. In the event that there are less than twenty (20) qualifiers, there would be no prizes awarded to any winners.
- e. Winners who are entitled to a prize will be notified by phone or email of their eligibility to receive the prize.
- f. The cash prize will be transferred to the MT4/MT5 account number provided by clients within the next 14 business days.
- g. The entitlement to the prize is exchangeable for cash at 70% of maximum prize value of the prize. The exchange price value (70% of maximum prize value) will be transferred to the account of the Trader Room (account attached to such Trader Room) from which the Client has requested to receive the prize.
- h. If the selected winner fails to reply within three (3) working days by email on the original communication, a new winner will be selected, and the prize will be forfeited.



- i. If Markets4you subsequently discovers or determines in its absolute discretion that a participant is not entitled to or is disqualified to participate in the Promotion or is unable to adhere to any terms and conditions in relation to the promotion, Markets4you shall, at its sole discretion, decide on the following:
  - i. Withhold the prize; and/or
  - ii. Re-claim the prize from the participant and select another qualified winner.

### F. Reservation of Rights and Disqualification

- a. Markets4you reserves the right at its reasonable discretion, to:
  - 1. Decline registration to any participant in the "Promotion".
  - 2. Disqualify any participant of the "Promotion" who violates or abuses the terms of use of Markets4you services.
- b. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the "Promotion". At any given time, we may ask the participant to provide personally identifiable information.
- c. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the "Promotion" without any prior notification.
- e. Markets4you reserves the right to alter, amend or terminate the "Promotion", or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the "Promotion". The participant is obliged to comply with all the rules and conditions of the "Promotion", as well as monitor changes in the relevant terms and conditions.
- f. Any fraudulent activity or attempts to manipulate the program will result in immediate disqualification and potential account suspension.
- g. If for any reason any "Promotion" is not capable of running as planned as a result of any (including but not limited to) technical failures, unauthorized intervention, tampering, fraud or any other causes beyond our control which corrupt or affect the administration, security, fairness, integrity or proper conduct of a "Promotion", we reserve the right to cancel, terminate, modify or suspend the "Promotion" and/or to disqualify any individual who (whether directly or indirectly) causes (or has caused) the problem.
- h. By participating in this program, clients agree to comply with all terms and conditions set forth by Markets4you.
- i. We may vary these General Terms or any Specific Terms or terminate a "Promotion" at any time at our absolute discretion if reasonably required to do so. Termination or variation of a "Promotion" is without liability to any entrant or other person. We will not award the prize if a "Promotion" is terminated.



- j. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- k. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the "Promotion", the user will not be entitled to any reward. Participants who attempt to abuse the "Promotion" or manipulate their position in the "Promotion" will forfeit their reward in favor of the next chosen user in line in the Promotion.
- I. If any participant is attempting to compromise the integrity or the legitimate operation of the "Promotion" by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets 4 you may terminate such a user account at its sole discretion. Further, Markets 4 you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the "Promotion" and/or ban the user from participating in any of future promotion and other promotions.
- m. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services.Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- n. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
