

## Gongxi Raya 2026 Promotion Terms & Conditions

### A. Introduction

The "Gongxi Raya 2026 Promotion" is a Markets4you Promotion (the "Promotion"). It is a special Promotion program exclusively for the Lunar New Year and Hari Raya Aidilfitri, where all clients who maintain a specific amount of InOut (net deposits) and trade a specific amount of lots, can participate in the lucky draw (the "Promotion")

### B. Participation in "Promotion"

- a. Markets4you Clients who meet the following criteria can participate:
  - i. Eligible Accounts: Cent Fixed, Cent Standard, Cent Pro, Classic Fixed, Classic Standard, Classic Pro on MT4 and MT5
  - ii. Markets4you Clients are defined as Markets4you Clients with accounts under the Markets4you and Share4you.
  - iii. Country: Indonesia and Malaysia

### C. Promotion Period:

The Promotion will take place from 01 February 2026, 00:00 (server time) to 31 March 2026, 23:59 (server time) (the "Promotion period").

### D. General Terms

- a. Clients need to click the Participation Button in the Trader Room to participate in the Promotion.
- b. During the Promotion period, clients who meet the following minimum requirements will earn one (1) ticket for the lucky draw:

Categories	Minimum InOut (Net Deposit)	Minimum Trading Volume (Lot)
Category 1	2000 USD	100 Lots
Category 2	1000 USD	50 Lots

- c. Clients can deposit and trade multiple times to get more tickets.

## E. Awards and Winners

- a. The winners of the Promotion will be drawn at random from the pool of eligible qualifiers, and there are eight (8) winners in total for the draw, including three (3) winners for Category 1 and five (5) winners for Category 2. The prizes are awarded according to the following table:

Categories	Prizes	No. of Prizes
Category 1	10 grams Gold Bar	3
Category 2	5 grams Gold Bar	5

- b. Each winner can only win one (1) prize per draw.
- c. The lucky draw will be conducted on 8th April 2026.
- d. Winners will be announced on 20th April 2026 via Markets4you's official social media channels.
- e. In order to claim the prize, the winner's Trader Room must be verified.
- f. Markets4you reserves the right to draw eligible winners to substitute any winner subsequently found to be ineligible or disqualified. Markets4you's determination of the winner shall be final, conclusive, and binding.
- g. In the event that there are fewer than thirty (20) qualifiers in Category 1, qualifiers will be joining the lucky draw for Category 2 and their tickets earned will be multiplied by 2.
- h. For example, Client A has InOut of 5000 USD and traded 230 lots, he fulfilled the Category 1 minimum requirements and earned 2 lucky draw tickets. But the total no of qualifiers in Category 1 is less than 20 people. Hence the Client A will join Category 2 lucky draw, and his tickets will be multiplied by 2, which is 4 tickets.
- i. In the event that there are fewer than thirty (30) qualifiers in Category 2, there would be no prizes awarded to any winners.
- j. Winners who are entitled to a prize will be notified by phone or email of their eligibility to receive the prize.
- k. The entitlement to the prize is exchangeable for cash at 70% of the maximum prize value of the prize. The exchange price value (70% of the maximum prize value) will be transferred to the account of the Trader Room (account attached to such Trader Room) from which the Client has requested to receive the prize within 14 working days.
- l. If the selected winner fails to reply within three (3) working days by email on the original communication, a new winner will be selected, and the prize will be forfeited.
- m. If Markets4you subsequently discovers or determines in its absolute discretion that a participant is not entitled to or is disqualified to participate in the Promotion or is unable to adhere to any terms and conditions in relation to the Promotion, Markets4you shall, at its sole discretion, decide on the following:
- Withhold the prize; and/or
  - Re-claim the prize from the participant and select another qualified winner.

## **F. Lots and Orders**

- a. Only trades involving instruments based on (i) currency pairs(including bitcoin), (ii) indices (excluding JP225, SG27, HK50), (iii) commodities , (iv) metals are taken into account in determining whether a particular client has satisfied the above mentioned minimum lot volume requirement.
- b. Hedged orders are taken into account in their total full lot volume only in the event that the second order (opposite direction order) was opened not earlier than 3 hours after the first order had been opened. Should the period between the openings of two opposite directed orders be equal to or less than 3 hours, the smaller order's volume would be counted in the calculations.
- c. All opposing positions, whether held within a single trading room or across multiple trading rooms by the same client or a group of affiliated clients, will be excluded from the calculation of the total lots
- d. InOut is defined as the Total Deposits subtract the Total Withdrawals during the Promotion period.
- e. Deposit bonus or Welcome Bonus funds and lots traded using such bonus funds will not be counted towards the Promotion.
- f. Total traded volume is counted from closed orders. Any orders that are open at the end of the Promotion will not be considered for the Promotion.
- g. The InOuts and traded volumes from all existing trading platforms will be assessed at the end of the Promotion Period.
- h. All calculations are done on Trader Room level.
- i. Markets4you will determine the final results of each Client. Data will be derived from data of Client's activity, but the Promotion result will not include:
  - i. Internal transfers;
  - ii. Any other monetary activity that Markets4you deems unfit.

## **G. Reservation of Rights and Disqualification**

- a. Markets4you reserves the right at its reasonable discretion, to:
  - i. Decline registration to any participant in the "Promotion".
  - ii. Disqualify any participant of the "Promotion" who violates or abuses the terms of use of Markets4you services.
- b. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the "Promotion". At any given time, we may ask the participant to provide personally identifiable information.
- c. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the "Promotion" without any prior notification.
- e. Markets4you reserves the right to alter, amend or terminate the "Promotion", or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the "Promotion". The participant is obliged to comply with all the rules and conditions of the "Promotion", as well as monitor changes in the relevant terms and conditions.

- f. Any fraudulent activity or attempts to manipulate the program will result in immediate disqualification and potential account suspension.
- g. If for any reason any "Promotion" is not capable of running as planned as a result of any (including but not limited to) technical failures, unauthorized intervention, tampering, fraud or any other causes beyond our control which corrupt or affect the administration, security, fairness, integrity or proper conduct of a "Promotion", we reserve the right to cancel, terminate, modify or suspend the "Promotion" and/or to disqualify any individual who (whether directly or indirectly) causes (or has caused) the problem.
- h. By participating in this program, clients agree to comply with all terms and conditions set forth by Markets4you.
- i. We may vary these General Terms or any Specific Terms or terminate a "Promotion" at any time at our absolute discretion if reasonably required to do so. Termination or variation of a "Promotion" is without liability to any entrant or other person. We will not award the prize if a "Promotion" is terminated.
- j. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- k. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the "Promotion", the user will not be entitled to any reward. Participants who attempt to abuse the "Promotion" or manipulate their position in the "Promotion" will forfeit their reward in favor of the next chosen user in line in the Promotion.
- l. If any participant is attempting to compromise the integrity or the legitimate operation of the "Promotion" by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets4you may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the "Promotion" and/or ban the user from participating in any of future Promotion and other Promotions.
- m. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services. Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- n. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
