

Terms & Conditions for "PAMM Master Challenge"

A. Introduction

- a. This document outlines the terms and conditions of the "PAMM Master Challenge" (the "Promotion") organized by Markets4you. All eligible clients who fulfill the necessary participation criteria are entitled to participate in this Promotion.
- b. AUM is defined as "Asset Under Management" which excludes the manager's capital.

B. Participation in "Promotion"

- a. Markets4you Clients who meet the following criteria can participate:
 - i. Participants must be registered as PAMM Money Managers with verified trading accounts.
 - ii. Only AUM brought in during the campaign period is counted.
 - iii. Managers must maintain positive performance with drawdown not exceeding 30% (Equity vs Balance).
 - iv. This promotion can be participated in by clients globally.
 - v. Clients can only register for this promotion through the designated landing page.

C. Promotion Period:

The Promotion will take place from 30th June 2025, 00:00 (server time), to 30th September 2025, 23:59 (server time) (the "Promotion period").

D. General Terms

- a. What Qualifies as AUM for the Campaign:
 - i. New Investor Deposits Only
 - 1. The company will count only fresh investor deposits made into the fund manager's PAMM account during the campaign period.
 - ii. Minimum Holding Period
 - 1. Funds must remain under management for at least 30 days to be eligible.
 - iii. No Self-Funding Allowed
 - 1. AUM must come from third-party investors. Self-deposits or wallet transfers from the fund manager's own accounts are excluded.
 - iv. Performance Criteria
 - 1. PAMM Managers must maintain a positive overall performance, with a maximum drawdown of 30%, calculated based on equity versus balance, which means floating losses (unrealized trades) are also taken into account when assessing drawdown levels.
 - 2. The account must show at least one trading activity within the promo period.
 - v. Minimum Investor Requirement
 - 1. Each fund manager must have at least 2–3 unique investors contributing to their AUM to qualify (prevents gaming with a single large deposit).



- vi. Only trades involving instruments based on
 - 1. Currency pairs including BTC
 - 2. Indices (excluding JP225, SG27, HK50)
 - 3. Commodities
 - 4. Metals
- vii. To ensure fair participation and to prevent abuse of the challenge mechanics, only trades that remain open for a minimum duration of **3** minutes (180 seconds) will be considered valid for volume calculation and performance evaluation.

b. What Will Be Excluded:

- i. Internal transfers or recycled funds from the same client under different accounts will be excluded.
- ii. Investors who withdraw funds before the 30-day holding period ends will be excluded.
- iii. AUM obtained via promotional or bonus capital.
- iv. Accounts that exhibit suspicious activity or have been flagged by compliance will be subject to review.
- c. Prizes:

Note: Fund Managers can only win one reward tier based on the highest AUM they reach

- i. Winners have the option to convert their prize into a cash alternative at 70% of the listed prize value. This option must be confirmed within 7 days of winner notification. The cash payout will be made via [MT4/MT5] within 14 business days after confirmation.
- ii. Number of winners is capped as follows:
 - 1. Tier 1: 20
 - 2. Tier 2: 14
 - 3. Tier 3: 5
 - 4. Tier 4: 3
- iii. If the number of qualifiers exceeds the cap, we'll rank managers based on AUM efficiency and trading activity to select the top performers only.



E. Reservation of Rights and Disqualification

- a. Markets4you reserves the right, at its reasonable discretion, to:
 - 1. Decline registration to any participant in the "Promotion".
 - 2. Disqualify any participant of the "Promotion" who violates or abuses the terms of use of Markets4you services.
- b. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the "Promotion". At any given time, we may ask the participant to provide personally identifiable information.
- c. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the "Promotion" without any prior notification.
- e. Markets4you reserves the right to alter, amend or terminate the "Promotion", or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the "Promotion". The participant is obliged to comply with all the rules and conditions of the "Promotion", as well as monitor changes in the relevant terms and conditions.
- f. Any fraudulent activity or attempts to manipulate the program will result in immediate disqualification and potential account suspension. In particular, the loss return may be revoked.
- g. If for any reason any "Promotion" is not capable of running as planned as a result of any (including but not limited to) technical failures, unauthorized intervention, tampering, fraud or any other causes beyond our control which corrupt or affect the administration, security, fairness, integrity or proper conduct of a "Promotion", we reserve the right to cancel, terminate, modify or suspend the "Promotion" and/or to disqualify any individual who (whether directly or indirectly) causes (or has caused) the problem.
- h. By participating in this program, clients agree to comply with all terms and conditions set forth by Markets4you.
- i. We may vary these General Terms or any Specific Terms or terminate a "Promotion" at any time at our absolute discretion if reasonably required to do so. Termination or variation of a "Promotion" is without liability to any entrant or other person. We will not award the prize if a "Promotion" is terminated.
- j. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- k. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the "Promotion", the user will not be entitled to any reward. Participants who attempt to abuse the "Promotion" or manipulate their position in the "Promotion" will forfeit their reward in favor of the next chosen user in line in the Promotion.



- I. If any participant is attempting to compromise the integrity or the legitimate operation of the "Promotion" by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets4you may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the "Promotion" and/or ban the user from participating in any of future promotion and other promotions.
- m. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services. Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- n. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
