

“Trade Insurance 2025 Promotion” Terms & Conditions

A. Introduction

The “Trade Insurance 2025 Promotion” is a Markets4you promotion (the “Promotion”). It is an exclusive promotion where all new and existing clients, who will make a new deposit of minimum of USD \$1,000 during the promotion period are eligible to receive a return of trading loss on up to client’s first 30 traded (opened and closed) orders within 2 business weeks during the promotion period.

B. Participation in “Promotion”

- a. Markets4you Clients who meet the following criteria can participate:
 - i. Both new and existing clients are eligible to participate.
 - ii. Eligible Accounts: Classic Pro, Classic Standard, and Cent Account of MT5 and MT4 servers.
 - iii. Applicable for regular trading accounts (including Share4you Leader / Follower accounts).
 - iv. Is not capable with other bonuses or promotions on Trader Room level.
 - v. 1 user can participate only with a single account during the promotion period.
 - vi. Country: Vietnam and India.
 - vii. Trader Room must be verified.

C. Promotion Period:

The Promotion will take place from 1st August 2025, 00:00 (server time) to 30th September 2025, 23:59 (server time) (the “Promotion period”).

D. General Terms

- a. Clients must make a minimum new deposit during the promotion period of USD \$1,000 and open at least 30 trades within 2 business weeks to gain eligibility to the promotion. All ‘Trade Insurance’ returns will be capped at a maximum of USD 20 per participant level.
- b. Each participant can join the promo only with a single trading/share4you account.
- c. All 30 trades opened and closed within 2 weeks after subscription to the promotion will be considered for loss return up to a maximum return of USD 20. Any trades that remain open after 2 business weeks will not be considered as eligible for return.
- d. Client can get compensation even if his overall 2-week trades are positive
- e. Clients need to send a message via Markets4you chat or Ticket with the message “Please review my 30 trades according to “Trade Insurance 2025 Promotion” for my account _____” mentioning the account that is used for that promo in order to participate.
- f. All the relevant loss will be credited to the account within 2 business weeks of the request from the client and will be added to the client account and can be withdrawn at any time using locally available withdrawal methods.

- g. The maximum leverage allowed on the client account during the promotion is 1:4000.
- h. To ensure fair participation and to prevent abuse of the challenge mechanics, only trades that remain open for a minimum duration of 3 minutes (180 seconds) will be considered valid for volume calculation and performance evaluation.
- i. Only trades involving instruments based on (i) currency pairs including BTC, (ii) indices (excluding JP225, SG27, HK50), (iii) commodities, (iv) metals qualify for the Promotion
- j. Only new deposits are considered during this promotion.
- k. This Promotion cannot be combined with other bonuses or promotions
- l. Calculation will be done on an account level (as client is allowed to participate only with 1 account at a time).
- m. Clients can deposit multiple times during the promo period to reach the necessary minimum deposit of USD 1000.
- n. The deposit count is derived from the following:
 - i. Direct Deposit from the payment system.
 - ii. Deposits using Local Depositors.

E. Reservation of Rights and Disqualification

- a. Markets4you reserves the right at its reasonable discretion, to:
 - 1. Decline registration to any participant in the "Promotion".
 - 2. Disqualify any participant of the "Promotion" who violates or abuses the terms of use of Markets4you services.
- b. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the "Promotion". At any given time, we may ask the participant to provide personally identifiable information.
- c. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the "Promotion" without any prior notification.
- e. Markets4you reserves the right to alter, amend or terminate the "Promotion", or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the "Promotion". The participant is obliged to comply with all the rules and conditions of the "Promotion", as well as monitor changes in the relevant terms and conditions.
- f. Any fraudulent activity or attempts to manipulate the program will result in immediate disqualification and potential account suspension. In particular, the loss return may be revoked.
- g. If for any reason any "Promotion" is not capable of running as planned as a result of any (including but not limited to) technical failures, unauthorized intervention, tampering, fraud or any other causes beyond our control which corrupt or affect the administration, security, fairness, integrity or proper conduct of a "Promotion", we reserve the right to cancel,

terminate, modify or suspend the “Promotion” and/or to disqualify any individual who (whether directly or indirectly) causes (or has caused) the problem.

- h. By participating in this program, clients agree to comply with all terms and conditions set forth by Markets4you.
- i. We may vary these General Terms or any Specific Terms or terminate a “Promotion” at any time at our absolute discretion if reasonably required to do so. Termination or variation of a “Promotion” is without liability to any entrant or other person. We will not award the prize if a “Promotion” is terminated.
- j. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- k. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the “Promotion”, the user will not be entitled to any reward. Participants who attempt to abuse the “Promotion” or manipulate their position in the “Promotion” will forfeit their reward in favor of the next chosen user in line in the Promotion.
- l. If any participant is attempting to compromise the integrity or the legitimate operation of the “Promotion” by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets4you may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the “Promotion” and/or ban the user from participating in any of future promotion and other promotions.
- m. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services. Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- n. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
