

“Terms and Conditions” for Markets4you Football Frenzy 2026

A. Introduction

- a. Participation in the *Markets4you Football Frenzy 2026* (“Promotion”) constitutes acceptance of these Terms and Conditions. By joining, participants agree to comply with all rules set by **Markets4you**.

B. Participation in “Promotion”

- a. Clients can only register for this promotion by clicking “Kick Off & Qualify Now” in the designated landing page and fill out all the required details.
- b. Participants need to possess the Markets4you account.
- c. **Multiple** accounts per client (Trader Room) are allowed to participate at any given time.
- d. To redeem the merchandise each participant must deposit and trade according to the required amount of deposit and trading lot stated into each of their trading accounts that they participate with, after the official start date of the competition.
- e. The merchandise awarded will correspond to the participant's highest level of achievement attained during the promotion period.
- f. Participation in this promotion requires that the qualifying deposit amount be maintained in the participating trading account throughout the Promotion Period. Any withdrawal that reduces the account balance below the applicable minimum deposit threshold set out in Section E will result in forfeiture of eligibility for the corresponding merchandise tier. For the avoidance of doubt, partial withdrawals that do not reduce the balance below the relevant threshold shall not affect participation.
- g. Share4you (Leader & Follower) and PAMM accounts are not eligible for participation.
- h. Only clients residing in Indonesia, India, Cambodia, Laos, Malaysia, Nigeria, Philippines, Thailand, and Vietnam are eligible to participate in this promo due to logistical constraints, including production capacity and shipping limitations.
- i. A client must be older than 18 years old and shall already have a valid real account registered with a valid email address to participate in this promotion.
- j. Participation in the Promotion is personal to the registered client and is non-transferable. Clients may not assign, transfer, or otherwise delegate their participation rights or any merchandise entitlement to any third party.

C. Promotion Period:

The promotion will take place from **16th March 2026, 00:00 (server time), to 15th May 2026, 23:59 (server time)** (the “Promotion period”).

E. Qualifying Criteria

a. Minimum Requirements:

b. Trading Lot Conditions:

- i. Only the following instrument categories shall be counted towards the trading lot requirements: Forex currency pairs, Bitcoin, Gold, Silver, and Energy.
- ii. For the avoidance of doubt, any instrument category not expressly listed in clause E.b.i above is excluded from valid volume calculation.

c. Minimum Trade Duration:

- i. Each trade must be open for a minimum of **three (3) minutes** to be counted towards valid volume.

F. General

a. Merchandise Distribution

- i. The merchandise will be distributed **3-4 business weeks** after the promo ends for final processing.
- ii. Upon shipment, the client will receive an email with a tracking number.
- iii. Shipment will be taking up to **2-3 business weeks** depending on regions.
- iv. Any unforeseen delays will be due to the local shipping company and clients may need to contact them for further assistance.
- v. Clients can redeem **more than 1** merchandise depending on their achievements.
- vi. For apparel merchandise, specifically the Track Jacket and Jersey, **size information may be required** from the qualified client.
- vii. The company representative will initiate contact via email to confirm the required size. Should the client **fail to respond within three business days** from the date the email is sent, the company reserves the right to issue any available size.

b. Limited Merchandise

- i. Allocation of merchandise is subject to limited availability and will be processed on a first-come, first-served basis once the necessary requirements are met.
- ii. Tier 4 merchandise option will be provided to the client based on availability.

G. Reservation of Rights and Disqualification

- a. Markets4you reserves the right, at its reasonable discretion, to:
 - i. Decline registration to any participant in the “Promotion”.
 - ii. Disqualify any participant of the “Promotion” who violates or abuses the terms of use of Markets4you services.
- b. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the “Promotion”. At any given time, we may ask the participant to provide personally identifiable information.
- c. Markets4you reserves the right to limit, block access to its services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the “Promotion” without any prior notification.
- e. Markets4you reserves the right to alter, amend or terminate the “Promotion”, or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the “Promotion”. The participant is obliged to comply with all the rules and conditions of the “Promotion”, as well as monitor changes in the relevant terms and conditions.
- f. Any fraudulent activity or attempts to manipulate the program will result in immediate disqualification and potential account suspension. In particular, the loss return may be revoked.

- g. If for any reason any “Promotion” is not capable of running as planned as a result of any (including but not limited to) technical failures, unauthorized intervention, tampering, fraud or any other causes beyond our control which corrupt or affect the administration, security, fairness, integrity or proper conduct of a “Promotion”, we reserve the right to cancel, terminate, modify or suspend the “Promotion” and/or to disqualify any individual who (whether directly or indirectly) causes (or has caused) the problem.
- h. By participating in this program, clients agree to comply with all terms and conditions set forth by Markets4you.
- i. We may vary these General Terms or any Specific Terms or terminate a “Promotion” at any time at our absolute discretion if reasonably required to do so. Termination or variation of a “Promotion” is without liability to any entrant or other person. We will not award the prize if a “Promotion” is terminated.
- j. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
- k. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the “Promotion”, the user will not be entitled to any reward. Participants who attempt to abuse the “Promotion” or manipulate their position in the “Promotion” will forfeit their reward in favor of the next chosen user in line in the Promotion.
- l. If any participant is attempting to compromise the integrity or legitimate operation of the "promotion" by hacking, cheating, or committing fraud or manipulation in any way, including by providing false details or false registration, Markets4You may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting rewards and/or deduct any such rewards' amounts that were given to such participants under the “Promotion” and/or ban the user from participating in any of future promotion and other promotions.
- m. Force Majeure. In no event shall Markets4you be responsible or liable for any failure or delay in the performance of its obligations hereunder arising out of or caused by, directly or indirectly, forces beyond its control, including, without limitation, strikes, work stoppages, accidents, acts of war or terrorism, civil or military disturbances, disease and pandemics (including, but not limited to, CoVid-19), nuclear or natural catastrophes or acts of God, and interruptions, loss or malfunctions of utilities, communications or computer (software and hardware) services. Markets4you shall use reasonable efforts which are consistent with accepted market practices as soon as practicable under the circumstances.
- n. These terms & conditions may have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
- o. We are not associated with the World Cup 2026.

H. Governing Law and Dispute Resolution

- a. These Terms and Conditions shall be governed by and construed in accordance with the laws of the British Virgin Islands.

- b. Any dispute, controversy, or claim arising out of or in connection with these Terms and Conditions, or the breach, termination, or invalidity thereof, shall be resolved through good faith negotiation between the parties. If the dispute cannot be resolved within thirty (30) calendar days, it shall be referred to and finally resolved by arbitration under the rules of Singapore International Arbitration Centre (SIAC).
- c. Nothing in this clause shall prevent Markets4you from seeking injunctive or other interim relief in any court of competent jurisdiction.

I. Data Protection

- a. By participating in this Promotion, clients acknowledge and consent to the collection, processing, and storage of personal data as necessary for the administration of the Promotion, including but not limited to name, email address, trading account details, shipping address, and apparel size information.
- b. All personal data collected in connection with this Promotion shall be processed in accordance with Markets4you's Privacy Policy, available on the Markets4you website.
- c. Personal data collected for the purposes of this Promotion will not be used for purposes unrelated to the administration and fulfilment of the Promotion, unless otherwise provided for in the Privacy Policy or separately consented to by the client.

J. Limitation of Liability

- a. To the maximum extent permitted by applicable law, Markets4you's total aggregate liability in connection with this Promotion shall not exceed the retail value of the merchandise to which the relevant client would otherwise have been entitled.
- b. In no event shall Markets4you be liable for any indirect, incidental, consequential, special, or punitive damages arising out of or in connection with this Promotion, including but not limited to loss of trading profits, loss of opportunity, or any claims arising from delays in merchandise delivery.
- c. Markets4you makes no warranties, express or implied, regarding the quality, fitness for purpose, or merchantability of any merchandise provided under this Promotion. Any defects or issues with merchandise shall be subject to the manufacturer's warranty terms, if any.

K. Tax Liability

- a. Participants are solely responsible for any tax obligations arising from the receipt of merchandise under this Promotion, including but not limited to income tax, customs duties, import taxes, or any other levies imposed by the relevant tax authority in their country of residence.
- b. Markets4you shall bear no responsibility for advising participants on their individual tax obligations, and participants are encouraged to seek independent tax advice where necessary.

L. Severability

- a. If any provision of these Terms and Conditions is found to be invalid, illegal, or unenforceable under the laws of any applicable jurisdiction, such invalidity, illegality, or unenforceability shall not affect the remaining provisions, which shall continue in full force and effect.

- b. Any invalid or unenforceable provision shall be deemed modified to the minimum extent necessary to make it valid and enforceable while preserving the original intent of the parties.

M. Entire Agreement

- a. These Terms and Conditions, together with the Markets4you General Terms of Use and Privacy Policy, constitute the entire agreement between Markets4you and the participant in relation to the Promotion, and supersede all prior or contemporaneous representations, understandings, or agreements relating to the subject matter hereof.
