

Terms and Conditions

Markets4you Trading Contest

A. Introduction

- a. Participation in the Markets4you Trading Contest 2026 (the “Program”) constitutes acceptance of these Terms and Conditions. By participating, entrants agree to comply with all rules established by Markets4you. Markets4you reserves the right to amend, suspend, or terminate the Program at any time without prior notice.

B. Participant in the “Promotion”

- a. Clients may register for this Program only by contacting Customer Support and providing their account user ID.
- b. Participants must have a verified Markets4you account.
- c. Share4you accounts (Leaders and Followers) and PAMM accounts are not eligible to participate.
- d. Only clients residing in **Vietnam** are eligible to participate in this Program.
- e. Clients must be **over 18 years old** and have a valid real trading account registered with a valid email address to participate in the Program.

C. Promotional Period:

The Promotion will run from 1 September 2026 at 00:00 (server time) until 30 September 2026 at 23:59 (server time) (the “Promotional Period”).

D. General Terms

- a. Eligible accounts:
 - i. **MT4 Classic Standard**
 - ii. **MT5 Classic Standard**
 - iii. **MT4 Classic Pro**
 - iv. **MT5 Classic Pro**
 - v. **MT4 Cent Pro**
 - vi. **MT5 Cent Pro**
- b. All deposits, withdrawals, fund transfers, and trading volumes across the eligible accounts belonging to the same client will be aggregated at the Trader Room level .
- c. “Net Deposit” means the total amount of eligible deposits minus the total amount of withdrawals made during the Promotional Period.
- d. Bonuses, credits, cashback, internal adjustments, reversed payments, and unsuccessful deposit transactions will not be included in the Net Deposit calculation.
- e. Each trade must remain open for at least three (3) minutes to count towards the eligible trading volume.
- f. Participants will be ranked only in the highest Tier for which they have met both the minimum Deposit and trading-volume requirements.
- g. Within each Tier, the winner will be determined based on the highest Net Deposit at the end of the Promotion.
- h. Markets4you will verify the final results within a maximum of three (3) business days after the Promotion ends.

- i. The final list of winners will be announced through Markets4you's official communication channels and/or communicated by email.
- j. If two or more clients within the same Tier have the same Net Deposit, the client with the higher eligible trading volume will rank higher.
- k. If both the Net Deposit and eligible trading volume remain equal, the client who first fulfilled the Tier requirements will rank higher, based on Markets4you's system records.

E. Eligibility Criteria

- a. Tier 1:
 - i. A minimum deposit of USD 5,000 and a minimum trading volume of 50 standard lots.
- b. Tier 2:
 - i. A minimum deposit of USD 10,000 and a minimum trading volume of 100 standard lots.
- c. Tier 3:
 - i. A minimum deposit of USD 25,000 and a minimum trading volume of 250 standard lots.
- d. Clients must meet both requirements for the relevant Tier. Meeting only the Deposit requirement or only the trading-volume requirement will not qualify the client for that Tier.

F. Prizes

- a. Rankings and Results:
 - i. Each Tier will have a separate leaderboard and will be assessed independently according to the criteria set out in Section D.
 - ii. Any leaderboard displayed during the Promotion is provisional and may change following the verification process.
 - iii. Each client may receive or redeem only one (1) prize throughout the entire Promotion, regardless of the number of participating trading accounts.

c. Prize Fulfilment

- i. Processing the list of winners may take up to two (2) business weeks. The final winners will be contacted by email for further verification.

- ii. Prize fulfilment may take up to two (2) business weeks after the client responds to the winner-verification email.
- iii. Prize images are for illustrative purposes only. The colour, storage capacity, version, or specific model will be subject to availability. Markets4you may substitute a prize with another product of equal or greater value if necessary.

G. Reservation of Rights and Disqualification

- a. Markets4you reserves the right, at its reasonable discretion, to:
 - i. Reject the registration of any participant in the Promotion.
 - ii. Disqualify any participant who breaches or abuses Markets4you's terms of service.
- b. Only users registered with Markets4you and residing in the applicable country are eligible to participate in the Promotion. We may request participants to provide personal identification information at any time.
- c. Markets4you reserves the right to restrict or block access to its services and/or terminate a user's account if the requested information is not provided. By providing information and registering with Markets4you, you confirm that all information submitted is true, accurate, current, and complete.
- d. Markets4you reserves the right, at its reasonable discretion, to discontinue the Promotion without prior notice.
- e. Markets4you reserves the right to change, amend, or terminate the Promotion, or any aspect thereof, at any time. Markets4you is under no obligation to notify clients of such changes. Participants are responsible for complying with all rules and conditions of the Promotion and for monitoring any amendments to the applicable terms.
- f. Any fraudulent activity or attempt to manipulate the Promotion will result in immediate disqualification and may lead to account suspension. Any profits arising from such activity may be clawed back.
- g. If, for any reason, the Promotion cannot operate as planned due to circumstances including, but not limited to, technical failures, unauthorised intervention, tampering, fraud, or any other causes beyond our control that affect the administration, security, fairness, integrity, or proper operation of the Promotion, we reserve the right to cancel, terminate, modify, or suspend the Promotion and/or disqualify any individual who directly or indirectly caused the issue.
- h. By participating in this Promotion, clients agree to comply with all terms and conditions established by Markets4you.
- i. We may amend these General Terms, any Specific Terms, or terminate the Promotion at any time at our sole discretion where reasonably deemed necessary. The termination or modification of the Promotion will not give rise to any liability towards any participant. No prizes will be awarded if the Promotion is terminated.
- j. Any indication or reasonable suspicion by Markets4you of any form of arbitrage, abuse, fraud, manipulation, or cashback arbitrage will render all transactions executed and/or any profits or losses recorded in the relevant trading account null and void.

- k. If a participant experiences data-integrity issues relating to their account statistics and is consequently unable to participate in the Promotion, the participant will not be entitled to any prize. Any participant who attempts to abuse or manipulate their position in the Promotion will forfeit their prize, which will be awarded to the next eligible participant.
- l. If any participant attempts to compromise the integrity or legitimate operation of the Promotion through hacking, fraud, or manipulation of any kind, including providing false information or making a fraudulent registration, Markets4you may terminate the participant's account at its sole discretion. Markets4you may also refuse to award the prize, deduct or recover any prize already granted, and/or prohibit the participant from taking part in future promotions.

Under no circumstances will Markets4you be liable for any delay or failure to perform its obligations arising directly or indirectly from events beyond its control, including, but not limited to, strikes, work stoppages, accidents, war or terrorism, civil or military disturbances, epidemics and pandemics (including, but not limited to, COVID-19), nuclear or natural disasters, or interruptions, losses, or malfunctions affecting utility, communication, or computer services, including software and hardware. Markets4you will use reasonable efforts, consistent with accepted market practices, to resume performance as soon as reasonably practicable under the circumstances.
- n. These Terms and Conditions may be prepared in several languages. Although all versions are deemed authentic and accurate, the English-language version will prevail in the event of any dispute.
