

Terms & Conditions for “Trade, Win & Celebrate”

A. Introduction

1. This document describes the terms and conditions of “Trade, Win & Celebrate” promotion (the “Promotion”) which is a Markets4you Client promotion. All Clients who fulfill the necessary requirements will qualify for participation in the Promotion. Top 3 clients from all participating countries with the highest deposit during the promotion period and another Top 17 clients from each country will be awarded with prizes.

B. Participation in Promotion

1. Markets4you clients who meet the following criteria can participate:
 - a. Country: India, Indonesia, Laos, Malaysia, Thailand, Vietnam, Nigeria, Russia, Kazakhstan and Uzbekistan.
 - b. Client’s Trader Room must be verified.

C. Promotion Period

1. The Promotion will take place from 6 May 2024, 00:00 (server time) to 31 July 2024, 23:59 (server time) (the “Promotion period”).

D. General Terms

1. Registration
 - a. All eligible clients will be automatically registered for this promotion.
2. Minimum requirements
 - a. In order to qualify for participation in the Promotion, clients must satisfy the following minimum requirements during the Promotion period:
 - i. Minimum accumulative deposit of USD 170;
 - ii. Minimum trading volume of 17 lots across all trading accounts within a Trader Room.
 - b. Additionally, the Top 3 clients to win the Grand Prize must satisfy the following minimum requirements during the Promotion period:
 - i. Minimum accumulative deposit of USD 1700;
 - ii. Minimum trading volume of 170 lots across all trading accounts within a Trader Room.

3. Winning
 - a. 17th Anniversary Giveaway
 - i. The Top 17 clients that satisfied the minimum requirements and accumulated the highest deposits in their country will be selected as winners for 17th Anniversary Giveaway.
 - ii. If two or more Clients have the same amount of accumulative deposits, the total traded lot will be the tiebreaker. Client with the higher trading volume will be the winner.
 - b. 17th Anniversary Grand Prize
 - i. The Top 3 clients that satisfied the minimum requirements for Grand Prize (D.2.b) and accumulated highest deposits among all participants will be selected as winners for 17th Anniversary Grand Prize.
 - ii. If two or more Clients have the same amount of accumulative deposits, the total traded lot will be the tiebreaker. Client with the higher trading volume will be the winner.
 - iii. Only one (1) winner from each country will be selected.
4. Calculations of the total deposit amount from trading platforms and the total lot volume traded are made from closed orders during the Promotion period.
5. Only trades involving instruments based on (i) currency pairs, (ii) indices and (iii) commodities qualify for the Promotion, that is, are taken into account in determining whether a particular client has satisfied the above mentioned minimum lot volume requirement.
6. Hedged orders will be considered in their total full lot volume only in the event where the second order (opposite direction order) was opened not earlier than in three (3) hours after the first one had been opened. Should a period between opening two oppositely directed orders be equal or less than three (3) hours, the smaller order's volume would be counted in the calculations.
7. Deposit bonus funds and lots traded on bonus funds (e.g., Deposit Bonus) will not be counted towards the client's participation in the Promotion.

E. Awards and Winners

1. There will be two prize categories in this Promotion:
 - a. 17th Anniversary Giveaway
 - i. Each Top 17 winner from each country will receive one (1) cash prize of 170 USD. A total number of 170 winners will be rewarded in this prize category.

- b. 17th Anniversary Grand Prize
 - i. Each Top 3 client among all participants will receive one (1) cash prize of 1700 USD and a Markets4you premium gift. A total number of 3 winners will be rewarded in this prize category. Only one (1) winner will be selected from each country.
2. Each Promotion winner is entitled to receive only one (1) prize regardless of how many categories the winner achieved.
3. Only winners announced and approved by Markets4you will be eligible to claim the reward offered.
4. Markets4you will respond via personal call, message or email notifying the winners of eligibility to receive the reward within thirty (30) working days of conclusion of the Promotion (or on such other date as Markets4you may, in its discretion, decide).
5. Should the client fail to reply to Markets4you's confirmation of the reward within five (5) business days via phone or email, such client will forfeit his/her reward, and a new winner will be selected.
6. Markets4you reserves the right to substitute any client subsequently found to be ineligible or disqualified. Markets4you's determination of the client's qualification shall be final, conclusive, and binding. Markets4you has the right to replace the reward with another reward.
7. The entitlement to the reward is not replaceable or refundable or transferable or exchangeable for gifts, vouchers or benefits in-kind, unless Markets4you deems it to be.
8. By accepting the rewards, clients unconditionally consent to the terms and conditions of the Promotion.
9. If Markets4you subsequently discovers or determines in its absolute discretion that a participant is not entitled to or is disqualified to participate in the Promotion or is unable to adhere to any terms and conditions in relation to the promotion, Markets4you shall, at its sole discretion, decide on the following:
 - Withhold the prize; and/or
 - Re-claim the prize from the participant and select another qualified winner.

F. Reservation of Rights and Disqualifications

1. Markets4you reserves the right at its reasonable discretion, to:
 - a. Decline registration to any participant in the Promotion.
 - b. Disqualify any participant of the Promotion who violates or abuses the terms of use of Markets4you services.
2. Only users who have registered with Markets4you and are from the relevant country are eligible to participate in the promotion. At any given time, we may ask the participant to provide personally identifiable information. Markets4you reserves the right to limit, block access to its

services and/or terminate the user account if such information is not provided. By providing us with the information and registering with Markets4you, you confirm that any information provided is correct, accurate, up to date and complete.

3. Markets4you reserves the right, at its reasonable discretion, to discontinue the Promotion without any prior notification.
4. Markets4you reserves the right to alter, amend or terminate the Promotion, or any aspect of it, at any time. Markets4you is not obliged to warn customers about changes in the Promotion. The client is obliged to comply with all the rules and conditions of the Promotion, as well as monitor changes in the relevant terms and conditions.
5. Any indication or suspicion, in Markets4you reasonable discretion, of any form of arbitrage, abuse, fraud, manipulation, cash-back arbitrage will nullify all transactions carried and/or profits or losses in that trading account.
6. If a participant experienced data integrity issues concerning account statistics and therefore did not participate in the prize draw, the user will not be entitled to any prize. Participants who attempt to abuse the prize draw or manipulate their position in the draw will forfeit their prize in favor of the next chosen user in line in the draw. If any participant is attempting to compromise the integrity or the legitimate operation of the draw by hacking or by cheating or committing fraud or manipulation in any way, including by providing false details or by false registration, Markets4you may terminate such a user account at its sole discretion. Further, Markets4you may refrain from granting prizes and/or deduct any such prizes' amounts that were given to such participants under the draw and/or ban the client from participating in any of future draws and other promotions.
7. These terms & conditions have been prepared in different languages, and whilst all versions are considered authentic and accurate, in case of any disputes the English language version shall prevail.
8. Markets4you reserves the right to disclose and publish the name, and such other particulars (including the photograph) of any participant/ winner in such mode and manner as Markets4you may at its sole discretion deem appropriate for publicity purposes and the participant/ winner agrees to be photographed, to the disclosure of his or her personal details, the use of his or her name, picture, image and voice for publicity purposes connected with the Promotion and to co-operate with and participate in the activities organized by Markets4you for this purpose without additional compensation.
9. All winners must share news of their award in social media prior to receiving the prize from Markets4you.
